# Report from RG.

- The ditch in front of the Club is full of silt. He will discuss this with the Club.
- The Community Transport Services bus service is unlikely to be introduced at this stage. The question of concessionary bus passes has still not been resolved.
- A cross-party group is looking into the question of children missing education, which currently numbers 2300.
- In the nominations for annual awards there is now a category for young carer.
- He will discuss with Robin Walbank of ECC regarding the Japanese Knotweed which is still flowering.

# Report from AK.

- Apologies for not attending previous meetings.
- The Planning Committee was collating evidence for the Stansted Airport application.
- A report on the Local Plan from the inspector is expected within the next two weeks. If the entire Local Plan is accepted then speculative development should cease.
- An Investment Board had been set up to consider all future investments.
- UDC currently has a cabinet system but may move to a committee system. This is being looked at by a working group to decide which works best for residents.
- A amount of £2000 is being made available via district councillors for local groups.
