#### Points noted:

- The finger post for Footpath 13 is covered in ivy, the sign barely readable. Requires a cut back.
- Bramble that is growing through the chicken wire boundary fencing to an allotment needs attention.
- Oak branches that overhang an allotment are going to be assessed and a quote given for the removal of the branches.
