375. Minutes of the last meeting

379. Birchanger pathway renewal and improvement scheme

Mike Newport (MN) from WSP gave full details of the intended scheme and the action taken so far. This information is contained in the report prepared by the parish clerk and already circulated to councillors.

There was considerable opposition to the intention to light the bridleway, and concern that the increased use by cyclists could increase the chances of accidents. MN had already passed on these concerns to Karl Brooks of Highways England. MN will investigate alternative methods of illuminating the bridleway such as reflectors, and also traffic calming methods. This information will be sent to the parish clerk.
