# 743. Planning

#### UTT/20/2403/HHF - 18 Harrisons, Birchanger

Demolition of existing rear extension and erection of single storey rear extension.

There is a small half a width of the property extension there at present. The plan is to demolish this and create what is going to be a very large extension to the rear going right across and it is large in depth as well. The house is semi-detached and this must impact upon the neighbour although the neighbour's house is set back more and may have been extended already. We would query the size. There used to be a guideline on the proportionality of an extension and this could exceed it. The gardens are large so that is not the problem. We would simply comment that the extension is very large and there are concerns about the impact of this upon the neighbouring property.

### 744. Reports from County and District Councillors

### Report from District Councillor Ayab Khan (AK)

There is due to be a full council meeting this week. One motion will be a response to the new planning proposals. It is anticipated that there are likely to be unplanned speculative developments.

#### Report from County Councillor Ray Gooding (RG)

- 92.5% of children have returned school. This compares with the national average of 88%.
- A number of people have taken the decision to home educate their children. There is a recommendation that a national register be kept of the children being home educated.
- There is an increase in children going into care.
- There has been an increase in the rate of Covid-19 cases in Uttlesford, to 60 per 100,000. The population of Uttlesford is 90,000.
- The best option to deter parking along Birchanger Lane past the ambulance station is to create a clearway. This will prevent parking on the verge. RG will investigate ownership of the land behind the verge.

RG has looked at the expanse of water adjacent to Gower Barn after the recent heavy rain. There is some concrete obstruction which is causing water to back up. He has reported the problem.

### 745. Parish Clerk's salary increase

GT said the clerk's performance had been satisfactory and recommended a scale point increase of 1 point to 17. This was agreed.
