## 840. Call for Sites

The UDC Planning Team is not involved with drawing up the new Local Plan and will not therefore be overseeing the Call for Sites. A new team has been formed to deal with the Local Plan. 299 sites have been registered with the Call for Sites, which could theoretically enable 70,000 new homes to be built. This is actually 57,000 more than is needed. Whilst the majority of these sites are in the South this does not prevent UDC approaching developers/landowners in the north.

17000 new homes will be needed by 2040 of which 4000 are in the pipeline. There are enough registered sites around Birchanger to allow the building of 3500 homes but the previous request to build a considerable number of homes around Birchanger was refused as the area is Green Belt. UDC would need to prove exceptionality to get permission to build in Green Belt. The decision about which sites have been selected will be made public towards the end of the year but further consultations will be held before then.

## 841. Noticeboard

The noticeboard at Bradley Common is in a very poor condition. Before a replacement is purchased, the Parish Council will look into the possibility of renovating the existing board.

## 842. Recreation Ground - New nets

The existing nets are in a poor condition. LP provided details of companies who can supply replacements. It was agreed to purchase new nets and spare clips.

## 843. Allotments - Rent review

It was agreed that allotment rent will increase to £15 p.a. with an annual review. The deposit is to be increased to £75.

## 844. Request for donation from Stansted Airport Watch (SAW)

A donation of £500 was agreed.
